

2. The above financial upgradations under ACP/MACP Scheme shall be purely personal to the individuals and shall have no relevance to their seniority position.
3. The above up-gradation will be further subject to the terms and conditions issued by DoP&T from time to time on the subject of ACPS/MACPS.
4. With regard to fixation of pay on grant of financial upgradation under MACP Scheme an individual may exercise option under FR 22(l) (a) (i) within in one month of the date of issue of this order.
5. Before granting pay fixation benefits under ACPS/MACPS to those individuals above whose date of admissibility is after the issue of this letter, Establishments will ensure that no Vigilance/disciplinary case is either pending or contemplated against them on due date of financial up-gradation.
6. The financial upgradation under MACPS granted earlier to Shri SI Lanjewar, JTO(D) (SI No. 07) and Shri MR Sonar, Sr D'Man (SI No. 8), as per details given below, may be treated as cancelled :-

(i) Shri SI Lanjewar, (SI No. 07) – 2<sup>nd</sup> MACP granted wef 01 Jan 2010 in the GP of Rs 4800/- vide SI No. 19 of DGQA/Adm-10 letter No. A/86611/AMMN/MACPS/13/DGQA/Adm-10 dated 25 Feb 2013.
