EX-POST FACTO SANCTION FOR UNLISTED INVESTIGATIONS/PROCEDURES

1. Reference Min of Health & FW OM No Z 15025/117/2017/DIR/CGHS/EHS dated 15 Jan 2018.
2. As per OM under reference, CGHS beneficiaries are required to seek prior permission for unlisted investigation (test)/treatment procedures from their department before undergoing such investigation/treatment. However, it has been experienced that CGHS beneficiaries of this office are getting the unlisted investigation done, even without emergency, as a routine and request competent authority to grant ex-post facto permission so as to make their medical claim admissible in Audit. This has also been adversely commented upon by the Audit authorities.
3. The Competent authority is of the opinion that this practice should be discouraged and ex-post facto permission in respect of unlisted investigation should be granted only in deserving case i.e. in case of emergency/urgent test.
4. In view of above, all CGHS beneficiaries of this office are hereby advised to adhere to CGHS guidelines and obtain prior permission before undergoing unlisted investigation/treatment procedure so that medical reimbursement can be done.
5. This may be brought to the notice of all concerned.
