1. 2. The above financial upgradation under MACP Scheme shall be pure personal to the individual and shall have no relevance to his seniority position.

With regard to fixation of pay on grant of financial upgradations under MACP Scheme an individual may exercise option under FR 22(I) (a) (i) within or month of the date of issue of this order, to get his pay fixed in the higher post/grade pay either from the date of his upgradations or from the date of his next increment viz. 1<sup>st</sup> July of the year. The pay and the date of increment would be fixed in accordance with clarification No. 2 of Department of Expenditure's OM No. 1/1/2008-1C dated 13 Sep 2008.

4. The above upgradations will be further subject to the terms and conditions issued by DOP&T from time to time on the subject of MACPS.

Before granting pay fixation benefits under MACPS to the individuals listed above, Establishments will ensure that no vigilance/disciplinary case is pending/contemplated against them, on due date of financial upgradation.

6. Necessary action may be taken by the concerned establishments to publish DO Part-II Order for information of their staff.
