3. With regard to fixation of pay on grant of financial upgradation under MACP Scheme an individual may exercise option under FR 22(1) (a) (i) within one month of the date of issue of this order, to get his pay fixed in the higher post/level either from the date of his upgradation or from the date of his next increment.

4. Necessary action may be taken by concerned establishments to publish DO Part-II Order for information of their staff. Before granting financial benefit under MACPS, establishments will ensure that no Vigilance/disciplinary case is either pending or contemplated against any individual.
