

IMPLEMENTATION OF E - TICKETING AND
DISCONTINUATION OF WARRANTS

1. E - ticketing project has been launched as a replacement for existing system of manual railway ticketing on warrants/concession vouchers (CVs) with its main aim to prevent wasteful expenditure in form of handling charges, non - refund post cancellation and also cost of printing and transportation of vouchers.
2. In this connection, a copy of DO letter by DG(OL&SM) to DGQA was forwarded to all Tech Coord by this office vide our note of even number dated 10.10.2017 requesting for implementation of E - ticketing in all DGQA units/estts. Copy of the same is again forwarded for ready reference.
3. Now DG(OL&SM), Travel Cell (E - ticketing) vide their letter dated 23.03.2018 (copy attached) has written to DG, DGQA to send confirmation of implementation of E - ticketing or clubbing of the units with major units in the vicinity.
4. In the light of above, DG, DGQA has directed that instructions be passed to all Tech Dtes for early implementation of E - ticketing in all DGQA estts.
5. It is, therefore, requested to issue necessary directions in this connection to all DGQA units/estts under your control to implement the same, at the earliest.
6. Confirmation/compliance report may please be sent to this office by 10.05.2018 for onward submission of the same to DGQA and DG(OL&SM).



IMPLEMENTATION OF E-TICKETING

1. PI ref D (Mov) Note No-3(2)/D (Mov)/2011 dt 05 Sep 2017 on Implementation of E-Ticketing Project under Defence Travel System (DTS) and DG OL & SM DO No 22005/Trg/ADG Strat Mov/E-Ticketing dt 10 Aug 2017 on the same subject.
2. It is intimated that vide the letters under ref, all units were to implement E-Ticketing by the end of Dec 2017, except for SFC or SFF which as of now have been excluded due to security clearance. Balance were to start E-Ticketing by collecting e-token or in case of minor units by clubbing with major units in the vicinity. The confirmation to this effect was to be forwarded to this office.
3. The data on implementation, held by this office still reflects 87 units under jurisdiction of DGQA which are without E-Ticketing.
4. The confirmation of implementation of E-Ticketing or clubbing of the units must be forward to this office by 30 Jun 2018. In case of any problems on the issue the same also must be reflected. For any clarification Col GS (Travel) can be contacted on above mentioned ASCON No.

Subject: Implementation of the E-ticketing project under Defence Travel System and discontinuation of warrants.

E-ticketing project was launched in June 2009 as a replacement for existing system of manual railway ticketing on warrants/concession vouchers (CV). Its main aim was to prevent wasteful expenditure in form of handling charges, non-refund post cancellation and also cost of printing and transportation of vouchers. It is based on internet web based portal known as Defence Travel System (DTS). It incorporates all Travel Regulation (TR) and units are issued with digital certificate based pen drive's known as e-tokens to access DTS. It is a cashless system wherein authority for travel, payment, accounting and budgetary control is inbuilt in the system.

2. The project is firstly being implemented in Defence Forces and thereafter will also cover Defence civilians. The project was envisaged in four phases, out of which phase I & II have been implemented and balance two are under process. The phases are listed as under:

- (a) Phase I: Implementation of E-ticketing for three services for rail (implemented).
- (b) Phase II: Extend the system to air travel (implemented).
- (c) Phase III: Extend the system to defence civilian.
- (d) Phase IV: Online submission of travel Allowance/Dearness allowance and claims.

3. The E-ticketing project is required to be implemented in all organisations, where Service officers are posted. Therefore, for implementation of DTS in your organisation, necessary coordination may be done with the following:-
