CLOSING OF APARs FOR YEAR 2018-19

1. Please refer to this office letter No 97118/Gen/APAR/DGQA/Adm-6B dated 31 Oct 2019 and 10 Dec 2019
2. As per the DoP&T guidelines, the entire activity of APARs for year 2018-19 was scheduled to be completed online at SPARROW on 31 Dec 2019. The same was revealed to all the concerns very well in time vide this office letters referred above.
3. Despite above, it has been notified that huge number of APARs in respect of DQAS cadre officers, PSSO & tenure officers and the personnel of group 'B' & 'C' are still pending at their respective stages of assessment. The DG, DGQA has taken a very serious view of the same. The officers liable for this unwanted delay in processing of APARs of 2018-19 will be identified by each Directorate for further necessary action.

Further, keeping in view of the volume of pendency of APARs and making the process streamlined, the closing date for completion of online APARs for all the categories of officers has been extended up to 15 Feb 2020. All Directorates are hereby advised to ensure the completion of entire process of APARs for 2018-19 within the extended date as mentioned above.
