5. Before granting pay fixation benefits under MACPS to those individuals above, whose date of admissibility is after the issue of this letter, Establishments will ensure that no Vigilance/disciplinary case is either pending or contemplated against them on due date of financial up-gradation.
6. Necessary action may be taken by concerned establishments to publish DO Part-II Order for information of their staff.
