**MINUTES OF 32nd ANNUAL MEETING OF THE GENERAL COUNCIL:
DGQA SPORTS CONTROL BOARD 2023-24**

1. The 32nd Annual Meeting of the General Council (AMGC) of DGQA Sports Control Board for the year 2022-23 was held at HQ DGQA, New Delhi under the chairmanship of Lt Gen RS Reen, DG, DGQA, President DGQA Sport Council Board on 22 Sep 2023 at 1030 hrs onward. The list of attendees is attached as Annexure 'A'.
2. Commencing the Meeting, Jt Secretary welcomed the President, Secretary Staff Side, Chairman of all Zones, DGQA Adventure Sports Cell and other Zonal Members of the DGQA Sports Control Board. Thereafter, the President addressed the forum and stressed need for conduct of sports keeping in view age profile of employees and work load.
3. HoEs of many establishments have informed that they are facing difficulties in smooth functioning of their office due to participation of appreciable number of employees in sports and, thus, requested for curtailment in numbers of days of organisation of sports event (tentatively 03-04 days). Also, during last JCM main meetings held under the chairmanship of DG, DGQA, the issue was raised by JCM members that there was inadequate medical facility for the injured players.
4. The following sports activities alongwith funds have been earmarked to zone mentioned against each:-

5. Audit Report, Treasurer's report and Observer's report are placed in the file of all council members for their information. There are no specific points to discuss in the council.

6. It has been unanimously decided that the senior most officer in the Zone will be the Zonal Chairman for better co-ordination among the Establishments under the zone. Moreover, it will also ensure the proper maintenance as well as audit of the ledger and accounts books pertaining to the Zonal Council of DGQA Sports Control Board.

7. A Lumpsum fund will be allotted to all Zonal Councils for conducting events and sending players to other zones for participation in the inter zonal sports events.

8. It was raised by the members of the Council that which type of leave will be applicable for the players who got injured during sports events. As per Constitution of the DGQA Sports Control Board "all competitors/officials including refries/judges/umpires participation in the tournament, athletic meets conducted directly by the Board or under the auspices of its Zonal Councils will be deemed to be on duty and entitled to draw their TA/DA as admissible". Accordingly, the injury so occurred during sports events will be treated as injury on duty and Work Related Illness and Injury Leave (WRILL) as promulgated by DoP&T vide OM No. 11020/01/2017-Estt. (L) dated 30 Aug 2019 will be applicable to such cases.


