

3. The promotion will be effective from 01 Jan 2024 or the date of assumption of charge in the higher grade of OS, whichever is later. The date on which the individual assumes duty as OS should be communicated to this HQ (DGQA/Adm-10) alongwith the necessary DO Part-II order.
4. Before the above mentioned individual assumes higher appointment, it may be ensured that no disciplinary case is pending against them.
5. The individuals will exercise option for fixation of pay on promotion within one month from the date of promotion as per FR-22-1(a)(i) except those who are already in the higher pay scale granted under MACP scheme.
6. As per directions contained in DoP&T OM No. 36012/11/2016-Estt. (Res-I) (Pt-II) dated 15 Jun 2018, promotion is subject to further orders which may be passed by the Hon'ble Supreme Court in SLP (c) No. 36021/2011 and various other SLPs on the subject matter.
7. Completion report should be sent to this HQ (DGQA/Adm-10) by 31 Jan 2024.
8. The officials are entitled to TA/DA and joining time, as admissible under the existing rules.
