**POSTING/ TRANSFER OF DQAS OFFICERS UNDER  
ROTATIONAL TRANSFER SCHEME-2024**


1. Ref MoD Posting/ Transfer Policy No. 43(1)/D(QA)/DGQA/Adm-7B/2016 dated 24 Nov 2016.
2. The list of DQAS officers who will be completing prescribed tenure by 30 Jun 2024 as per policy under ref and station wise details of existing vacancies as on date are enclosed at Annexure 'A' & 'B' respectively.
3. HoEs are requested to ensure that the names of all officers who are eligible for rotational transfer under RTS-2024 have been included in the list and if name of any officer have been inadvertently left out same may be communicated to this HQ by 15 Dec 2023.
4. HoEs are requested to strictly follow policy directives while forwarding recommendations, so that **the officer acquires wider exposure. The total cumulative tenure of any officer in the same station shall not exceed 12 years in entire service career and no officer should be posted back to the same station within next 03 years of his transfer.** The following aspects shall be kept in mind:-
  - (a) Central Govt servants have All India Service Liability.
  - (b) Posting profile shall ensure that individuals are posted to different stations thus the officers acquire wider exposure.
5. Officers listed in Annexure 'A' are requested to submit their preference of posting (minimum three station choices) through their Head of Estt (HoE)/ Technical Dte along with their latest paramount card to this HQ latest by 25 Dec 2023.
6. The case(s) for compassionate ground posting, duly recommended by HoE, shall be in accordance with the policy under ref. **A person posted on compassionate grounds will be allowed to exercise such a request only once in his full service tenure.** This aspect must be checked and brought out before processing of compassionate grounds case. Recommendation should clearly spell out the sub clause of clause 8 of policy under ref against which a particular case is recommended. Application for compassionate ground posting along with latest paramount card of officer should reach this HQ latest by 25 Dec 2023.

7. Please note that the vacancy position may increase/ decrease due to the ongoing DGQA restructuring process. Accordingly, posting/ transfer will be considered by the collegiate based on workload and total manpower available with the Directorates.
