**DELEGATION OF POWERS:**  
**SUBMISSION/PROCESING OF MEDICAL CLAIMS**

1. The undersigned authorizes ADG (Adm)/link officer as Head of Office (HOO) in terms of MoH&FW/DOP&T O.Ms and MoD letter in respect of all the civilian DGQA employees posted outside HQ DGQA as follows:-

Authority	Subject
(a) MoH&FW OM Nos. 1967/2013/DEL/CGHS/SZ/D52-CGHS(P) dated 10 Dec 2015 and S.11011/20/2014-CGHS(P)/EHSS dated 23 Nov 2016 as amended	Ex-post facto sanction for re-imbusement of medical expenditure for treatment availed in emergency with a ceiling limit of Rs 5 lacs.
(b) MoH&FW OM Nos. S.14025/8/99-MS dated 25 May 1999.	Condonation of delay in submission of medical claims/Sanction of time-barred claim.

2. All the Controllers, SQAOs and QAOs (irrespective of their pay scales) will exercise the powers as HOO only to grant a medical advance, issue of letter for providing credit facility to CGHS/CS(MA) beneficiaries admitted in recognized hospitals for emergency treatment and prior permission for taking treatment in CGHS empanelled hospitals as mandated by the MoH&FW under CGHS scheme or CS(MA) Rules. Similarly, in respect of other offices and wings/detachments which are headed by other functionaries, the Head of Offices to be so decided by the respective Controllers, will exercise these powers only to grant medical advance, issue of letter for providing credit facility to CGHS/CS(MA) beneficiaries admitted in recognized hospitals for emergency treatment and prior permission for taking treatment in CGHS empanelled hospitals as mandated by the MoH&FW under CGHS scheme or CS(MA) Rules.

3. For other specialized treatment (such as procurement of hearing aid; Denture etc.) where MoH&FW has provisioned for mandatory prior permission from Head of Department, ADG Adm/Link Officer, DGQA will also be the sanctioning authority as HOO in respect of DGQA civilian employees.

4. This HQ letters No. 98717/Policy/DGQA/Adm/RMD(US) dated 19 Jan 2012, 20 Apr 2012 and 19 Jun 2018, are hereby superseded.
