RELEASE OF DIRECT RECRUITMENT VACANCIES : 2014-15


1. Competent Authority has approved the release of civilian posts (Gp 'C') for the year 2014-15 for direct recruitment by the Estt concerned. The details of the posts released to establishments are mentioned in the Appendix to this note.
2. Technical Directorates are requested to inform and instruct their concerned Estts. to initiate the Direct Recruitment action. NAC has been obtained from AG's Branch vide their Note No. **15703/Opt/NAC/DGQA/Adm-7B/MP-4(Civ)(b) dated 24 Sep 15** (copy enclosed). The above NAC is valid for two years from the date of issue i.e, till 23 Sep 17 and all recruitment action for the said posts should be completed by that date.
3. All concerned will need to calculate the vacancies which are required to be reserved for Physically Handicapped persons and Ex-Servicemen in accordance with extant Government provisions. In this connection DOP&T OM No. 36012/58/92-EST(SCT) dated 01 Dec 1994 and OM No. 36035/3/2004-Est(RES) dated 29 Dec 2005 may also be referred. Reservation for SC/ST/OBC will be determined as per the reservation roster maintained by the Estts. or AHSPs concerned. In this connection DGQA/SCT Cell letter No. A/90690/DGQA/SCT Cell dated 02 Jan 2013 also refers.
4. Recruitment action is to be taken as per Recruitment Rules in vogue. It may be ensured that while filling up the above posts, the rules and guidelines on procedural formalities on reservation/promulgation of select list, medical examination/police verification etc must be complied with. Any violation of the rules and guidelines or existing Govt orders on procedure for recruitment by any officer, besides cancellation of present allotment for filling up of vacancy, shall render concerned officer liable for disciplinary action.
5. **It may be ensured that no interview is be carried out for selection of the candidates. The selection will be made on the basis of written test only. Written test may be designed to asses the overall suitability of the candidates to the post. Skill test of qualifying nature may be conducted where ever required. The above provision be clearly indicated in the advertisement seeking applications from the eligible candidates.**
