**SANCTION FOR TWO ADDITIONAL BSNL BROADBAND
CONNECTION FOR HQ DQA (R&S) SECUNDERABAD**

1. In terms of Serial No. 1(ii) of delegation of financial powers of DGQA issued vide Gol,MoD/D(QA) Letter No. 63921/Delegations/DGQA/ADM/Budget/1577/ D(QA) dated 12 Nov 2018, sanction of the Competent Financial Authority i.e ADG(Adm) with administrative approval of DG, DGQA is hereby conveyed to incur an expenditure of **Rs. 19176/- (Rupees nineteen thousand one hundred seventy six only) + GST (recurring charge of Rs. 799 per month per connection $799 \times 12 \times 2 = \text{Rs. } 19,176/- + \text{GST}$) (Fibre BSNL Plan 799)** under Broad-band plan of **BSNL only**. The list of sanctioned Internet connections alongwith details of expenditure per month is enclosed as Appendix 'A' to this note.

2. All Internet connections will be provided on separate stand alone computers and will not be used for other purposes. The internet computer and communication line sockets will be kept separate for security purpose. The computer system will not be connected to any WAN/LAN.

3. Security instructions issued from time to time related to Computer Security & Cyber Security by Ministry of Home Affairs and Ministry of Defence will be strictly complied with by the user office and requisite certificate/undertaking will be issued on monthly basis by the respective HOEs, who will be the Nodal officer for compliance of Departmental Security instructions.

4. Format of the Initial Certificate to be duly signed by the respective HOEs enclosed as Appendix 'B' be forwarded directly to Director DGQA/SDCC, 'B' Block, Africa Avenue, Sarojini Nagar PO, New Delhi-110023 for records under intimation to this HQ.

5. The expenditure involved is debitible to Major Head 2076, Minor Head 109C, (Sub Code Head 382/30) Misc Expenditure of the Defence Services Estimates.
