

PAYMENT OF PRODUCTIVITY LINKED BONUS (PLB) TO DGQA EMPLOYEES
POST CORPORATIZATION OF ORDNANCE FACTORY BOARD (OFB)

1. Case pertaining to grant of payment of Productivity Linked Bonus (PLB) to DGQA employees post corporatization of Ordnance Factory Board (OFB), has been taken up with MoD.
2. Following clarifications have been sought by MoD:-
 - a) What is the change, if any, in work profile of Group 'B', Non-Gazetted and below employees of DGQA after corporatization of OFB?
 - b) What bonus (PLB/Non-PLB) is given to DGQA employees rendering QA duties for stores of DPSUs (other than those created from erstwhile OFBs) and procedure for grant of bonus followed in their case may be furnished?
 - c) Estimated financial implication on payment of PLB vis-a-vis Adhoc Bonus (Non-Bonus) for year 2022-23 to the employees of DGQA.
3. In view of the above, Tech Dtes are requested to forward their inputs w.r.t. the employees under their Administrative control, as sought by MoD, as indicated above, for further processing the case.
