
DRAFT SENIORITY ROLL OF SENIOR STORE SUPERINTENDENT (SSS)
AS ON 01 SEP 2022

1. Draft Seniority Roll of Senior Store Superintendent (SSS) as on 01 Apr 2022 was circulated vide this office note No. A/86611/Sen List/SSS/DGQA/Adm-10 dated 12 Apr 2022.
2. On the basis of the observations/feedback received from Estts, the Seniority Roll of SSS has been updated as on **01 Sep 2022** and is forwarded herewith as **Appendix** to this Note. Tech Dtes are requested to circulate the same to all concerned establishments under their control. Establishments may be directed to show the Seniority Roll to all concerned individuals and obtain their signature in token of their having seen the Seniority Roll.
3. It is further informed that Reservation in promotion in respect of Persons with Benchmark Disabilities (PwBDs) has been introduced vide DoP&T OM No. 36012/1/2020-Estt. (Res-II) dated 17 May 2022 [circulated vide DGQA(Coord) Note No.A/90911/MoD-Misc/DGQA(Coord) dated 15 Jun 2022 to all Tech Dtes].
4. Discrepancies/objections, if any, either observed by the Establishments or pointed out by the individual in respect of the following aspects may be intimated to this HQ (DGQA/Adm-10) duly verified from Service Book of the individual by Head of the Estt, latest by **28 Oct 2022** positively:-
 - (a) Name
 - (b) Date of Birth
 - (c) SC/ST Status
 - (d) Present Establishment
 - (e) Date of Appointment in the present grade
 - (f) Seniority Position
 - (g) Omission of any name in Seniority Roll
 - (h) Requirement of deletion of name due to resignation, VRS, Death, etc.
5. **Categories of PwBDs (including sub categories as per Para 2.2 of DoP&T OM dated 17 May 2022, referred at Para 3 above) may be duly verified from the Service Records and a copy of Disability Certificate issued by competent medical authority may be forwarded in each case. Further, copies of Disability Certificate in respect of the Office Superintendents against whom the category of 'PH' has been indicated in the Seniority Roll may also be forwarded to this office.**
6. In case no communication is received within the stipulated period, it would be assumed that there are no discrepancies in the Seniority Roll.

The candidates who do not comply with the instructions will be treated as ineligible for the category.

4. The candidates who are not eligible for the category are required to produce the following documents to the Department within the specified time limit. The candidates who do not produce the documents within the specified time limit will be treated as ineligible for the category.

6. In case of any discrepancy is observed between the Security Roll and the list of candidates, the candidates are required to produce the documents to the Department within the specified time limit.
